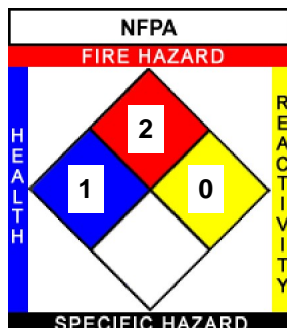

3 HAZARDS IDENTIFICATION
