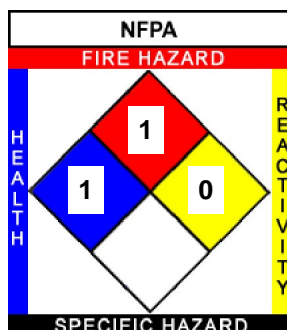

### 3 HAZARDS IDENTIFICATION
